**Mr. Bill Siksay (Burnaby—Douglas, NDP):** Thank you, Mr. Chair, and congratulations on your election, and to the vice-chairs as well.

The Chair: Thank you.

Mr. Bill Siksay: I was first elected in 2004 in the riding of Burnaby—Douglas, but I worked in Burnaby—Douglas for 18 years before that, first, briefly here on the Hill, and then for 16 years in the constituency office.
