1. Economic Recovery and Growth

Given the current climate of federal and global fiscal restraint, what specific federal measures do you feel are needed for a sustained economic recovery and enhanced economic growth in Canada?

3. Demographic Change

What specific federal measures do you think should be implemented to help the country address the consequences of, and challenges associated with, the aging of the Canadian population and of skills shortages?

Work with labour and community groups who have real ideas for doubling CPP and making sure that no Canadian senior lives in poverty. Make is affordable for all Canadians to go to university or trade schools and get the skills this country needs - whether that means lower tuition fees, more financial assistance, housing, day care and more schools in remote communities. We have people who want to work but who can not access jobs and training due to location or health issues.

4. Productivity

With labour market challenges arising in part as a result of the aging of Canada's population and an ongoing focus on the actions needed for competitiveness, what specific federal initiatives are needed in order to increase productivity in Canada?

First and foremost the Canadian government needs to stop companies from running away with jobs and money to cheap off shore locations. If you get money from Canada to expand and then run off to a cheaper location outside of Canada there needs to be repercussions.
