As an RCIC and as a member in good standing with ICCRC, I am expected to abide by a high set of standards of ethical behaviour ensuring that I am always abiding by the Code of Professional Ethics. ICCRC administers a robust complaints and discipline process to ensure that all RCIC's comply with the Code of Professional Ethics and that the consumers are effectively protected. Failure to comply with the code subjects us, as members, to disciplinary proceedings.

Immigration is a very complicated process and there are many who cannot complete an application on their own and need professional help and guidance. But having a solid reputation is paramount and the support of our government that sees us as stakeholders that can actually help increase efficiency by submitting complete files, rather than deal with delays and incomplete applications is so important.
